SUBMISSION OF ARTICLES



1. Article submissions, which must be original in content, should be made online via the Taylor & Francis Submission Portal. New users should first create an account. See overleaf for instructions for uploading a manuscript.
2. Authors should prepare and upload two versions of their manuscript. One should include the name and affiliation of the author or authors. The second must be anonymous, for the purposes of blind peer review.
3. Submitted articles must not be simultaneously under consideration for publication elsewhere.
4. Articles should be accompanied by the following information:
 - An abstract of 150 words or less.
 - Keywords or terms, to be used for indexing purposes (5-8). These terms should include the continent or region and the country/countries dealt with in the article, as well as other words reflecting the subject matter.
 - A title that clearly demonstrates the theme of the article, for purposes of easy discoverability in library and internet databases.
 - A brief bio for each author, for the 'note on contributors' at the end of each article.
 - The name, title, institutional affiliation, postal address, email address, and telephone number of each author. Where applicable, the ORCID identifier, LinkedIn name, and other social media IDs of the author are requested.
 - If there is more than one author, please indicate which will serve as the primary correspondent on the paper.
5. Article length should be between 6000 and 9000 words, **excluding** references and other endnotes.
6. References should appear in Chicago Notes style (endnotes). See the [SAIIA style guide](#) for more details on references.
7. Articles should be typed double-spaced, in font-size 12.
8. Tables and figures should be clearly labelled, with keys and source notes. The tables/figures may either appear in the paper, or be presented in a separate file clearly marked as such.

9. All submissions accepted for further consideration will be subject to double-blind peer review, after which reviewer comments will be sent to the author along with the Editor's decision.

10. Authors should carefully proofread their articles before submitting them. Articles with typographical, spelling and grammatical errors do not make a good first impression, and may be rejected prior to peer review.

11. Plagiarism is regarded as a serious offense. Any idea or quotation from another source must be fully acknowledged in the endnotes and references.

12. The use of Artificial Intelligence to generate data or content must be noted in the methodology section of the article, and the author will be held responsible for the veracity of content and references.

13. Permissions for the reproduction of any figure, table, or extract from the text of another source (even derivative) are the responsibility of the author. 14. Special issue proposals should be emailed to journal@saiia.org.za and sajia.editor@saiia.org.za. Guest editors are expected to develop a concept note, and assist with promotion of the call for papers, vetting submissions and selecting peer reviewers. Prospective guest editors are encouraged to contact SAJIA at least nine months before their ideal publication date.

Instructions for uploading a manuscript:

Step 1: Visit the submission portal by finding the link on [this site](#).

Step 2: Log in using existing account details, or log in after creating an account by clicking 'Create a Taylor & Francis account'.

Step 3: Once logged in, click the 'submit new manuscript' button.

Step 4: In the 'Submit to' search box, search for and select 'South African Journal of International Affairs'.

Step 5: Answer all the questions and at the bottom of the page select 'Research Article' as article type. Then click 'Start'.

Step 6: Complete the manuscript details page, where you will upload your article (two versions, one with author details and one anonymous, designated as such) and click 'Next'.

Step 7: Complete the keywords page and click 'Next' — insert a minimum of five keywords or key terms.

Step 8: Complete the authors information page and click 'Next'.

Step 9: Check the preview and, if everything has been captured correctly, click 'Submit'.
